The last 12 months have been an extraordinary time for the NHS and all at #teamHDFT with the COVID-19 pandemic continuing to test everyone in the health and social care sectors. HDFT Governor Elections

Have your say as to who should represent Harrogate and surrounding villages, and Knaresborough and East Districts on our Council of Governors.



Three is the magic number



Being a Governor is a big responsibility, so what makes someone want to take on the role? HDFT's Lead Governor, Clare Illingworth reveals all.

Becoming a governor for an NHS trust was the furthest thing on my mind when in 2005 I decided to make a life and career changing decision.

At the time, I had been working in the catering industry for 18 years and was running a successful restaurant in North Yorkshire. However, I had started to feel that there was something missing in my life and the more I thought about it, the more I realised that I no longer had the passion to be a restaurateur and I needed to change my career. The ideal opportunity appeared when I saw an advert for the role of sterile services secretary at Harrogate District Hospital and decided to apply for the post.

Over time, I became more interested in the work of the wider Trust. In 2015, the ideal opportunity presented itself when I heard about an election to become one of the Trust's governors. I felt this would help me learn more about the role of the Trust and give something back by playing a significant role in its future direction. It wasn't an easy decision as at the time it felt way out of my comfort zone, but with considerable thought I realised it was an opportunity I would be foolish to turn down.

I had only been a staff governor for 18 months when I was thrust straight into a significant organisational case for change – the Trust was considering creating Harrogate Healthcare Facilities Management Ltd (trading as Harrogate Integrated Facilities (HIF)), a wholly owned subsidiary, to supply services to Harrogate District Hospital and community services such as maintenance, sterile services, portering, catering, security, waste management, and domestics. Within my role as a staff governor, I have had to

wear many hats. As well as being a staff governor, I am a manager, a member of staff, and part of #teamHDFT, roles which would all be impacted by the change. Even now, three years later, the governors are focussed on monitoring HIF performance and whether it has met the objectives it was set up to achieve.

I had become very passionate about my role as staff governor and the opportunities it provided to instigate positive change, but unfortunately when I was transferred to HIF I had to relinquish my staff governor role. I was keen to ensure that the Trust did not lose representation from HIF and that staff in this subsidiary still had a voice. In July 2018, following my expressions of interest I was appointed as the nominated stakeholder governor for HIF. In 2019, the lead governor position became vacant at the Trust. Having relished my role as firstly a staff governor, then stakeholder governor, I decided to see if I could add a third string to my bow as lead governor and put myself forward.

I was delighted to be chosen as lead governor and took up the post in January 2020, but little did I know what I was about to face. Within weeks the first COVID-19 case was confirmed in the UK. Life as we knew it changed almost overnight. The last year and a half have been an extraordinary time for the NHS and quite unlike anything we have experience in living memory. The pandemic meant our Trust was working harder than ever before and the way we operated also needed to change to cope with the demands. The board were excellent at providing extra briefings for governors, and as with most of society, we embraced the wonders of the digital age, especially video conferencing, with all of our meetings being converted to a virtual platform.



As restrictions and lockdown were introduced and people were being furloughed or having to work from home, I was able to commit as much time as was required for both of my leadership roles – as a medical professional and as a governor. I felt that as the Trust was faced with such pressures it was important that I was heavily involved in its future direction. While there is nothing that can replace a face-to-face meeting, modern technology has had many advantages. We have found governors have been able to attend more meetings, including ones that they may have otherwise not been able to attend due to travel.

As the lead governor, I felt that I needed to attend as many as I could to ensure the governors were represented at all forums. Staff governors have also had to deal with additional pressures as they had to prioritise their roles as NHS employees during the pandemic. While Microsoft Teams and Zoom have been a blessing in helping us to keep the wheels turning, the lack of face-to-face interaction has been hard.

Being a governor can be both challenging and rewarding. I have worked at the Trust for more than 16 years and been a governor for the last five years. Being a governor has added a new perspective and dimension to my role and it is the chance to make a real difference for both my colleagues and the people in my community that makes it so worthwhile. It can be time consuming attending quarterly council meetings, board meetings and informal briefings with the board (which includes both the exec and non-executive directors), but is extremely rewarding knowing you are being listened to and your views are helping to shape the Trust's future.

On reflection, I wish I had pondered less and probed more when I first started. I believe that you can only have an effective Council of Governors if you have good leadership, so I joined the National Lead Governor Association which enables me to understand my role better and operate more effectively as a leader. I was also very recently elected as the new chair of the association which has enhanced my responsibility and I will strive to continue with the fantastic leadership of my predecessor.

The past year has touched the lives of everyone including governors. As I have previously mentioned, staff governors have endured the additional challenges of the pandemic, working within the NHS while also committing to their governor roles. However, they have at least been able to see each other during their day-to-day roles. Public and stakeholder governors have relied solely on technology to conduct the business of the council, which has meant a different set of challenges. While meetings have continued as normal, the virtual platform is not quite the same and does not provide the chance for opportunist conversations at meetings or with the public and patients in the hospital or community.

The COVID-19 pandemic brought many challenges, and I am sure there will still be a few more to come. But, as a Council of Governors at HDFT we have managed to adapt and overcome the difficulties we have faced, provided a voice for our colleagues and played an important part in helping our beloved NHS to care for our communities. I have been fortunate to have experienced the governor role through all my lenses, as a member of staff, a stakeholder and as a lead. Do I wish I'd stayed in the restaurant industry? No, I much prefer helping create a recipe of success for HDFT.

Election Countdown

A number of seats on HDFT's Council of Governors are up for election this winter with voting closing at 5pm on Thursday 16 December 2021. We have a number of exceptional candidates, but who would you choose?



There are less than two weeks to go before the HDFT Governor Elections take place and many of you may still be deliberating as to who you should vote for.

Whilst 18 elected and six nominated governors sit on the Council, this month three public governor positions are up for election which you may be eligible to vote for - two for Harrogate and surrounding villages, and one for Knaresborough and East District. Members in each constituency can vote for a candidate to represent them on the Council of Governors.

These governor vacancies have arisen due to governors coming to the end of their term of office or where the seat has not been filled in the previous election round.

Foundation Trusts are part of the NHS but they are governed locally instead of centrally. They have a membership - people who want to get more involved in local health services sign up to become members.

Foundation Trusts are accountable to their members through a Council of Governors. The Governors

play a vital role in shaping the future direction of HDFT and the services provided to local communities. They represent the interests of the Trust's membership (which includes staff, patients and local residents) and the wider public.

HDFT cares for the population in Harrogate and the local area as well as across North Yorkshire and Leeds. We also provide children's services in the North East in County Durham, Darlington, Middlesbrough, Stockton-on-Tees, Gateshead, Northumberland and Sunderland. Our Governors play a pivotal role in helping shape the future direction of the Trust.

This year, we have a number of candidates from a variety of backgrounds who are up for election and across the following pages you will find election statements from each candidate to help you make up your mind.

If you are a member of the Trust and have a governor election taking place in your constituency, you will have received a voting form either by email or in the post. Simply follow the instructions to make your vote count.

New era for Northumberland health visiting and school nursing services

In October HDFT took over running Northumberland's 0-19 Healthy Families Service. As the biggest provider of 0-19 Healthy Family Services in the UK (we also operate this service for County Durham, North Yorkshire, Middlesbrough, Darlington, Stockton, Sunderland and Gateshead), we take great pride in providing the highest possible levels of care for children, young people and their families, so that they can get the best possible start in life.

The service in Northumberland will continue to be delivered locally by the same health visitors and school nurses, retaining their local knowledge of Northumberland, their key relationships with children, young people, their families and other stakeholders and remaining local and accessible across the county's varied geography.

Steve Russell, Chief Executive of HDFT said: "Although our Trust name is Harrogate and District, we already provide services across the North East, and we will now have bases in Northumberland too. We are looking forward to working closely with the current team of Health Visitors, School Nurses and other staff who currently provide this service - who will continue in their roles and still be based in Northumberland to ensure there is no disruption to the service.

"We take great pride in providing high levels of care for children, young people and their families so that they can get the best possible start in life and our aim is to develop and improve on the current service to better meet the needs of the community."



Covid update & visiting

The number of patients in our hospital with COVID-19 has gradually reduced from a recent peak of 30 patients, to around 10-15 patients. This has followed a reduction in the rates of infection in the community. We will continue to keep the same infection control measures in place and have also encouraged COVID-19 vaccinations and boosters for all of our staff. The emergence of the new Omicron variant brings some uncertainty as we are not yet clear how this might impact the spread of COVID-19 or the numbers of patients requiring hospital care.

If visiting, please help by following the guidance below:

- Put on a clean surgical mask, wear it over your nose and mouth for duration of your visit, and wash your hands or use the hand sanitisers.
- If you are attending outpatients try to visit alone to reduce number of people in the waiting area.
- If you are visiting someone on a yellow ward, all patients may have one visitor by appointment, for 30 minutes between 2:00pm and 4:00pm.
- We can only allow two visitors in the entire bay at a time to allow social distancing. When you arrange your visit, you will complete a checklist to see if you are able to visit. If you are unwell, have COVID now or had contact/live with someone with COVID please postpone the visit.
- Please just sit on the chair with your relative and do not walk around the bay.
- On leaving the bay, please wash or sanitise your hands and again on leaving the ward.
- Visiting may change at short notice if a bay requires temporary closure for an infection.

If you have any concerns regarding the above, please discuss with the ward staff.



Elective care

Over the last 18 months the COVID-19 pandemic has impacted on the health service in so many ways.

During this period, much planned care unfortunately had to be paused. The development of effective vaccines, and the reduction of infections requiring hospital treatment has meant we have been able to gradually increase the amount of elective care we are able to provide. We are doing all we can to reduce waiting times for treatment or surgery. To ensure we are addressing the needs of those patients who have waited for the longest and those with the highest clinical priority, we are working collaboratively with other acute trusts to ensure they can be seen as quickly as possible.



Winter pressures

The winter months always bring with them additional pressures. We have secured funding to support additional ambulance transport to safely get patients home and employed additional staff to create a transfer team which will support the movement of patients around the organisation more efficiently. We are supporting additional pharmacy staffing to help improve the timeliness of discharges at a weekend and are also working hard to create some additional winter ward capacity to ensure we can keep treating both our emergency and planned patients through the winter period. Following the holiday period we are planning a 'perfect week' approach to create additional capacity as quickly as possible.



Becoming greener

HDFT (alongside the wider NHS) is committed to becoming a greener, more environmentally friendly and sustainable organisation. Improvements are currently being undertaken to help reduce our energy consumption, and in the future we will also be generating our own energy on site by drilling a borehole to extract heat. To help us achieve our aim of becoming greener, we are enlisting our colleagues help. Plans are underway to establish a Green Champions network consisting of colleagues from across the Trust who can help us to promote the green agenda and provide valuable ideas on what HDFT can do to become greener.



Developing our strategy for the future

To improve the health and wellbeing of everyone we serve, HDFT is embarking on a refresh of its Trust Strategy and Clinical Strategy. We would like patients and their families, the public, our members and our staff to get involved and have their say.
